

# BACHELOR OF SCIENCE IN HOSPITALITY AND TOURISM MANAGEMENT – ASSOCIATE DEGREE FOR TRANSFER (2011) ROADMAP

This is a sample pathway for students who transfer to San Francisco State University in the current Bulletin year with an AS-T in Business Administration. Up to 18 units in the major [ACCT 100, ACCT 101, possibly DS 212, ECON 101, ECON 102, HTM 120] and all lower-division GE requirements have been satisfied. Check with a major advisor about the most appropriate course sequence. **Degree completion guaranteed in 60 units**; see the Associate Degree for Transfer (ADT) section for more information (<http://bulletin.sfsu.edu/undergraduate-admissions/transfer-students/>).

Enough total units to reach 120 minimum for graduation; 30 units minimum at the upper-division level; to include the following:

## University-wide requirements: 9-15 units

- American Institutions (0-6 units): US History, US Government, California State and Local Government requirements if not met pre-transfer.
- Upper-Division GE Areas B, C, and D (9 units): Courses required for the major also satisfy UD GE.
- Students entering the major with the AS-T in Business Administration are not required to fulfill the SF State Studies or Complementary Studies requirements.

## Hospitality and Tourism Management major: 54-57 units [15-18 units completed in ADT. Statistics may or may not be complete]

- Major Core (42-45 units)
- Guided Electives (12 units)

## University Electives: 0 or more units

Depends on course choices made at the community college, how transferred units are applied to the requirements above, and course choices at SF State - some courses may meet more than one requirement, e.g. in both UD GE and the major.
